The full dumpster was picked up at town hall today. We plan to get another one in the next few days.

The Mayor told the Council about the bid quotes we have received for having the exterior cleaned and painted on our water tank. A bid from Eagle Water Tank Inspections Service (in Arkansas) for \$11,250.00. A second quote was previously received from Pittsburg Tank (Kentucky) for \$29,604.00. The Mayor said she was trying to get a third quote.

NEW BUSINESS

Mayor Newbury conducted the first reading of Ordinance #01-2017 "Condemning and abating nuisance properties." She also had the first reading of Ordinance #02-2017 "Town beautification ordinance". The 2nd and 3rd readings will take place at the June and July meetings by title only. The final vote will take place at the July meeting. Mr. Clawson moved, and it was seconded by Mr. Eads, to accept the 1st readings of Ordinance #01-2017 and Ordinance #02-2017. The roll call vote was unanimous. The motion passed.

The April, 2017 financials were presented and examined by the Council. Mr. Clawson moved, and Ms. Jones seconded the motion, to accept the April Financial reports as presented. The roll call vote was unanimous. The motion passed.
