Call to order

At roll call the following members were present: Mr. Holland, Ms. Linder, Mr. Newbury, and Ms. Seymore. Ms. Jones was not present.

Mr. Newbury moved, and it was seconded by Ms. Linder, to accept the Minutes of the previous meeting (August 10, 2021). The roll call vote was unanimous. The motion passed.

Old business

The on-going problem with extending U-Alley was on the agenda last night. Mr. Kelly and Mr. Hill were present and stated that they would like to extend U-Alley to develop lots that they have bought. Several citizens that own property on U-Alley had already stated that did not want U Alley to be extended; they want the alley to be abandoned and had requested such in the July Council meeting. After each side was given time to express their opinions, the Council voted to abandon a small portion of the alley as stated in Resolution #114-21. Ms. Seymore moved, and it was seconded by Mr. Newbury, to vacate a small portion of U-Alley. The roll call vote was unanimous. The motion passed.

The Council gave their permission to open a separate Simmons bank account for the use of our Coronavirus State and Local Recovery Funds, as required by Federal guidelines for use of this money: The bank account will be titled American Rescue Plan Act. The council voted to give signatory authority for Clara S. Gilmore, Linda J. Newbury, and James Q. Holland, as with all the Town's other accounts. We will use these funds to improve infrastructure in the manner of the floors in Mrs. Gilmore's office and in Mr. Culp's office, as well as other uses. Ms. Seymore moved, and it was seconded by Ms. Linder, to open stated new bank account. The roll call vote was unanimous. The motion passed.

New Business

The Mayor presented Resolution #115-21 to the council. This is an annual resolution to levy taxes on all taxable property, both Real and Personal, subject to taxation within the Corporate Limits for the year 2021.

Ms. Seymore moved, and it was seconded by Ms. Linder to adopt the Resolution #115-21. The roll call vote was unanimous. The motion passed.

Financials

The Council approved financials from June, 2021. Ms. Seymore moved, and it was seconded by Mr. Newbury, to approve the financials. The roll call vote was unanimous. The motion passed.
