## Call to order Roll call

A quorum being established, Mayor Newbury called the meeting to order. At roll call the following members were present: Mr. Holland, Ms. Jones, Ms. Linder, Mr. Newbury and Ms. Seymore.

### **Minutes**

Mr. Holland moved, and it was seconded by Ms. Seymore, to accept the minutes of the previous meeting (November 10-20). The roll call vote was unanimous. The motion passed.

#### Old business

The limb cutting has been completed. Our Public Works Supt. (David Culp) bought up the observation that some of the remaining limbs look like they are rotten and that at a later date the limbs would have to be cut or the tree taken down.

The Council campaign financial reports are due in the town hall office. They will be kept in the office.

Mr. Jim Seymore was scheduled to address the Council, but he didn't show up. Mayor Newbury told the Council that Mr. Seymore was not happy with the ditch project beside his house. He told the Mayor that if the town did not put in a culvert for his property that he would take further measures.

### **New Business**

The Mayor asked the Council for suggestions for 2021 Budget. She said that she was working on it and they would approve this budget in the January meeting.

The AD&D cards were given to the members to be signed and changes to be made for their beneficiary, if necessary.

Mrs. Newbury is in discussion Mr. William Hood of Communities Unlimited, about getting a rural development grant with a 50% match to repair the floors at Town Hall.

Mr. John Haen asked to be scheduled on the agenda to address the Council about closing an alley at his house. He didn't show up at the meeting.

Mayor Newbury told the Council that she was still trying to get a state trooper to make random trips to Felsenthal, but have not gotten a return call from him. She told the Council that she would continue to work to make this happen. In addition, the Council wants County patrols on a regular basis.

Mrs. Newbury told the Council that there was a problem with one of our property owners who has been causing problems with other persons in our town. This person's dog, running loose against town ordinances,

attacked another dog and caused several hundred dollars worth of veterinarian bill damage to this dog. In
addition, this person chased down a couple of guys and threatened them with a gun. This is all on video. The
Sheriff's office was called, and the Mayor is going to follow up on what is going to be done about this
problem.
