## February 8, 2011

Mayor Linda Newbury calls the meeting to order. At roll the following members were present: James Holland, Troy Clawson, Margurite Neal, John Newbury and Virginia Harris. In old business Joe Harris reported on the sewer pump on Short Circle. It has been replaced with a rebuilt pump. Joe told the council that if a pump goes out we can have one shipped to us in just a couple of days. Mrs. Harris made a motion, 2nd by Mr. Clawson to wait until we have a pump to go out to buy a new one. At roll call all members voted yes. Motion passed.

Mayor Newbury discussed the drainage that was done on Short Circle by the county. The county will fill pot holes for us as soon as the weather permits.

Mayor Newbury let the council see the website that is being prepared for the Town of Felsenthal. We will be able to post minutes, financial reports plus a number of things. She encourages input from the people. The website can be found at **www.felsenthalar.com**.

In new business Joe Harris reported on the problems with the chlorinator. After replacing old lines Joe has the chlorinator working properly. Joe reported we have a spare chlorinator and he is working on preventive maintenance.

Stray dogs in the Town of Felsenthal were discussed. There are too many dogs running around town without collars and no one claims them. We need to find out our legal rights. A motion was made by Mr. Clawson 2<sup>nd</sup> by Mr. Newbury to check with Crossett to see how they handle the problem. At roll call all members voted yes. Motion passed.

The neglected property around the Town was discussed. Mr. Newbury made a motion 2<sup>nd</sup> by Mrs. Harris to have Mrs. Newbury prepare an ordinance and present it at the March council meeting.

George Bounds made a presentation on the Felsenthal Bream Festival. It will be held on Memorial Day weekend May 27& 28, 2011.
